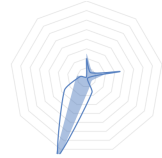

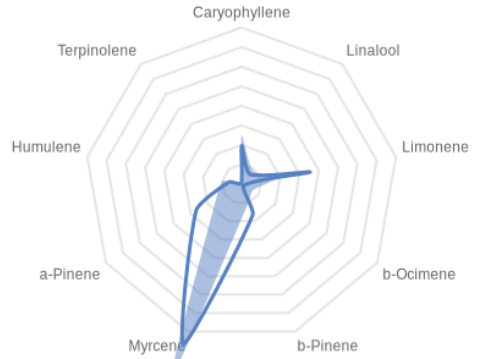

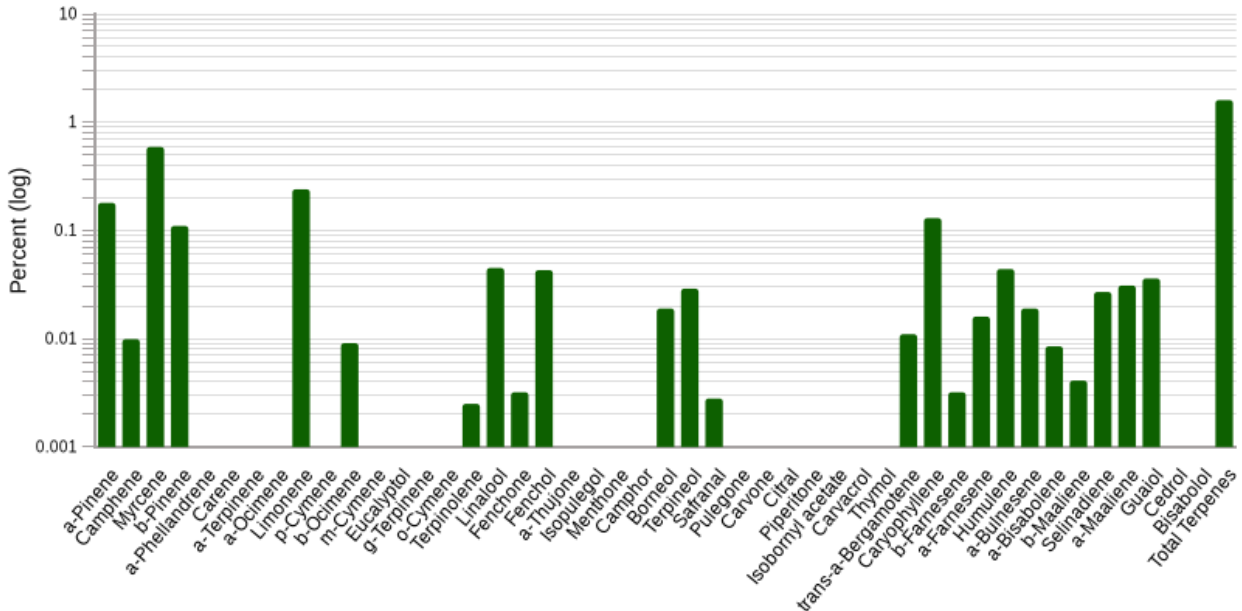


Spark Industries - Flower
